Insurance:

in coordination with HJ (Ad-Hoc & RCM Balto)

- Still in the beginning stages of gathering info & getting quotes
- Will go by the approx. number of people in our Region
- NEED: approx. count of each HG's numbers. Do not need names
- Application went to the Underwriter 3 weeks ago for QUOTE ONLY
- INCLUDE: the states for our Region: MD, VA, PA, DE but NOT include NEFA & 1 other Area
- EXCLUDE: because of our meeting (see May 2015), NEFA says they have no need for insurance & therefore this is a moot point for us. The Region was looking to cover ALL meetings in our Region, & would assess each Area its share of the premium. We are finding out if we can exclude specific Areas.
- FOR NEFA: If we exclude: If you have an incident (fall or get hurt) while at a meeting, NA event, etc you will have NO COVERAGE under FSR Insurance Policy. Please carry back to your HG & advise them. This is not final yet.
- CONCERN: Some groups in Balto are in NEFA towns & vice versa. We asked HJ to check it out.
- COVERAGE under NA Parent Organization: WSO continue to say that they do not have to pick up coverage. They stand by this & want each Region or Area to get their own insurance. For further questions, please see me & I will give you the Balto RCM information to get involved.

SERVICE SYSTEM PROJECT: How much have you spent on this?

We were going to put this in the CAR but John wrote to WSO & Steve Rush responded:

\$317,630 aggregate costs so far for the Service System Project. (meetings, literature, training, travel)

FSR is asking WSO why so much money is being spent when there is resistance to this. Some Regions are for these changes within our Service System & others are not, creating a huge break-away for many Areas & Regions. Some Areas will detach from the Region & be a stand-alone Area without a Region to support. (This is beginning in one Area in Florida.) MD has not expressed an acceptance of the changes. We will continue to follow this.

WORLD CONVENTION: I asked John if we had the numbers yet from WCNA in Brazil. We do not. Will it be another financial loss like San Antonio WCNA? Since WCNA did not properly prepare for this convention, did we take a hit on attendance & funds? John to find out.

RDA Report: Dee
